This is further to our letter dated May 25, 2016 on the subject matter wherein it was informed that the Board of Directors, at its meeting held on the same day i.e. May 25, 2016, had approved a proposal to acquire the exclusive online and offline rights to the global brand - Forever 21, for the Indian market and its existing store network in India from the current franchisee of Forever 21 i.e., Diana Retail Private Limited ("Diana Retail").

We wish to further inform you that the Company has today i.e. on July 5, 2016, executed a Business Transfer Agreement with Diana Retail and DLF Brands Limited (the promoter of Diana Retail), for the acquisition of the business undertaking of Diana Retail relating to the business of operating retail stores in India for the sale of clothing, artificial jewellery, accessories and related merchandise under the Forever 21 brand and also through ecommerce channels ("Forever 21 Undertaking") on a going concern basis, by means of a "slump sale" (as defined in Section 2 (42C) of the Income Tax Act, 1961), for a lump sum consideration and certain other matters incidental thereto.

We also wish to inform you that the Company has executed a franchise agreement with Forever 21, Inc. in terms of which the Company has been appointed the exclusive franchisee for the brand "Forever 21" for the Indian market.
