9.	Refer to the Resolution description and cast your vote by selecting your desired option 'Favour / Against'. (If you wish to view the entire Resolution		
	on the 'View Resolution' file link).		
10.	After selecting the desired option i.e. Favour / Against, click on 'Submit'. A confirmation box will be displayed. If you wish to confirm your vote, click on		
	'Yes', else to change your vote, click on 'No' and accordingly modify your vote.		
11.	Once the vote on a resolution is cast by the member, such member shall not be allowed to change it subsequently.		

## **REMOTE E-VOTING: POINTS TO REMEMBER**

- 1. Institutional shareholders (i.e. other than Individuals, HUF, NRI etc.) and Custodians are required to log on the e-voting system of LIIPL at <a href="https://instavote.linkintime.co.in">https://instavote.linkintime.co.in</a> and register themselves as 'Custodian / Mutual Fund / Corporate Body'. They are also required to upload a scanned certified true copy of the board resolution /authority letter/power of attorney etc. together with attested specimen signature of the duly authorised representative(s) in PDF format in the 'Custodian / Mutual Fund / Corporate Body' login for the Scrutinizer to verify the same.
- 2. If you have forgotten the password:
  - Click on 'Login' under 'SHARE HOLDER' tab and further Click 'forgot password?'
  - Enter User ID, select Mode and Enter Image Verification (CAPTCHA) Code and Click on 'Submit'.
- 3. In case shareholders/ members is having valid e-mail address, Password will be sent to his/ her registered e-mail address.
- 4. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential.
- 5. During the voting period, shareholders/ members can login any number of time till they have voted on the resolution(s) for a particular "EVEN".
- 6. Shareholders/ members holding multiple folios/demat account shall choose the voting process separately for each of the folios/ demat account.
