Accordingly, the Company received the first and final call on 2,73,464 shares during the quarter and is in the process of credit / obtaining Trading approval.

4b) 32,463 shares on which 'Rights Issue - first & final call money' has been received were pending for completion of regulatory process relating to process of credit/ obtaining Trading approval and the same have been considered as ₹ 7.5 paid-up

The above mentioned shares will get reflected in the Shareholding Pattern for the quarter ended March 31, 2022, subject to regulatory clearances.
