Please be informed that the 1<sup>st</sup> Meeting of the Board of Directors of the Company for the Financial Year 2019-20 will be held on <u>Wednesday, May 15, 2019</u>, to *inter alia* consider the Audited Financial Results of the Company for the Financial Year ended on March 31, 2019 ["said results"].

Please note that pursuant to the amended SEBI (Prohibition of Insider Trading) Regulations, 2015 ["SEBI PIT Regulations"], the Company has adopted a revised Code i.e. "Code of Conduct to regulate, monitor and report trading by Designated Persons in listed or proposed to be listed Securities of Aditya Birla Fashion and Retail Limited" w.e.f. April 1, 2019 ["the Code"]. The Code:-

- a) states Company's policy to be followed by the Designated Persons for dealing in securities of the Company and also
- b) restricts the "Designated Persons and their immediate relatives" from trading in securities of the Company during certain specific period(s), known as "Shut Period".

In terms of Clause 4 of Schedule B of SEBI PIT Regulations and the Code, the Company intended to close its trading window, 15 days prior to the date of Board Meeting for considering the said results by the Board of Directors of the Company. However, pursuant to the circulars issued by NSE and BSE, late evening on April 2, 2019, the Company has decided to close its trading window for dealing in securities of the Company w.e.f. <u>Friday, April 5, 2019</u> and it shall remain closed until 48 hours after the announcement of the said results.

The same has been duly communicated to all the Designated Persons under the Code.
