EXPLANATORY STATEMENT

[PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013]

The following statement sets out all material facts relating to the special business mentioned in this Notice:

Item No. 1 Re-appointment of Mr. Nish Bhutani (DIN: 03035271) as an Independent Director:

Mr. Nish Bhutani was appointed as an Independent Director at the 13th Annual General Meeting of the Company held on September 7, 2020, for a period of 5 (five) years, effective from June 5, 2020 until June 4, 2025. Accordingly, the tenure of Mr. Bhutani, as an Independent Director is due for expire on June 4, 2025.

He is proposed to be re-appointed for a second term of 5 (Five) Consecutive years as an Independent Director of the Company.

Pursuant to the performance evaluation of Mr. Bhutani and considering the vast experience and significant contributions made by him during his tenure as an Independent Director, as well as the belief that his continued association would be beneficial to the Company, the Board of Directors, based on the recommendation of the Nomination and Remuneration Committee ("NRC"), *vide* its circular resolution dated April 15, 2025 has approved the re-appointment of Mr. Bhutani as an Independent Director of the Company for a second term of 5 (Five) Consecutive years commencing from June 5, 2025 until June 4, 2030, subject to the approval of the Members of the Company being sought *via* this Postal Ballot Notice.

The profile and areas of expertise of Mr. Bhutani is provided separately in **Annexure A** to this Notice.

The Company has received a Notice proposing the candidature of Mr. Bhutani for the office of Director under Section 160 of the Act.

Mr. Bhutani has provided a declaration to the Board, stating that he:

- a. meets the criteria of independence as provided under Section 149(6) of the Act and Regulation 16(1)(b) of SEBI Listing Regulations;
- b. is qualified to be appointed as a Director in terms of Section 164 of the Act and has provided his consent to act as a Director;
- c. is not been debarred from holding the office of a director by virtue of any order passed by Securities and Exchange Board of India or any other such authority;
- d. is not aware of any circumstance or situation that exists or may be reasonably anticipated that could impair or impact his ability to discharge his duties as an Independent Director of the Company in term of Regulation 25(8) of the SEBI Listing Regulations and
- e. is in compliance with Rules 6(1) and 6(2) of the Companies (Appointment and Qualification of Directors) Rules, 2014 of the Act, with respect to his registration with the data bank of independent directors maintained by the Indian Institute of Corporate Affairs.

In the opinion of the Board of Directors, Mr. Bhutani is a person of integrity, possesses the relevant expertise and fulfills the conditions specified in the Act and the SEBI Listing Regulations for his re-appointment as an Independent Director and he is independent of the management.

Except Mr. Bhutani, none of the Directors and Key Managerial Personnel of the Company and/or their relatives are deemed to be concerned or interested (financially or otherwise) in the proposed Special Resolution, except to the extent of their shareholding in the Company, if any.
